

Random walks on \mathbf{R} and ordered trees : First applications.

Abstract

We study some sets of probabilities associated to a random walk on \mathbf{R} . These sets are also called averages induced by diffusion in J. Ecalle's resummation theory. They are strongly related to ladder epochs for a random walk on the real axis : an average is a set of "weights" indexed by words of plus or minus signs and, for a given word $(\varepsilon_1, \dots, \varepsilon_n)$ ($\varepsilon_i = \pm$), the weight of the average is simply the probability to be on $\mathbf{R}^{\varepsilon_1}$ at time 1, on $\mathbf{R}^{\varepsilon_2}$ at time 2, \dots , on $\mathbf{R}^{\varepsilon_n}$ at time n .

Such a coefficient can be decomposed in a sum of elementary coefficients which are indexed by *ordered trees and forests*.

The proof for the tree-decomposition is based on combinatorial methods, as well as a result of E. Sparre Andersen on a formal series associated to first ladder epoch probabilities. This result can also be recovered with the help of the tree-decomposition.

We also prove that this decomposition, which is valid for any random walk on \mathbf{R} , gives back, for the simple random walk, the well-known bijection between Dyck paths and Catalan trees.

1 Introduction.

There exists a vast literature about random walks on \mathbf{R} (see, for example, [6]) and, among numerous results, we could cite one, by E. Sparre Andersen, which is based on combinatorial methods.

Let $(X_n)_{n \geq 1}$ be a sequence of independent, identically distributed, real random variables, with a common probability density $f \in L^1(\mathbf{R})$. We can define the associated random walk, that is the collection of random variables $(S_n)_{n \geq 1}$:

$$\forall n \geq 1; \quad S_n = X_1 + \dots + X_n$$

Considering the probabilities associated to the *first ladder epoch* :

$$\forall n \geq 1; \quad \tau_n = P(S_1 \leq 0, \dots, S_{n-1} \leq 0, S_n > 0)$$

E. Sparre Andersen found that :

$$\log \frac{1}{1 - \tau(s)} = \sum_{n=1}^{+\infty} \frac{s^n}{n} P(S_n > 0) \quad \text{with} \quad \tau(s) = \sum_{n=1}^{+\infty} \tau_n s^n \quad (1.1)$$

The reader could refer to [6] for a proof. On the one hand, the theorem remains valid if the variables X_n share the same arbitrary distribution, but on the other hand, in the present conditions ($f \in L^1(\mathbf{R})$), the result holds whether the inequalities are strict or not.

As a corollary, if f is even,

$$\tau(s) = 1 - \sqrt{1 - s} = \sum_{n=1}^{+\infty} \frac{2}{4^n} ca_{n-1} s^n \quad \left(\forall n \geq 0; \quad ca_n = \frac{(2n)!}{n!(n+1)!} \right) \quad (1.2)$$

These results illustrate how combinatorial methods lead to an “explicit” computation of probabilities.

Let us consider generalizations of the “first ladder epoch”. We define the collection \mathbf{m}_f of probabilities (or *weights*) :

$$\forall n \geq 1; \quad \forall (\varepsilon_1, \dots, \varepsilon_n) \in \{+, -\}; \quad \mathbf{m}_f^{\varepsilon_1, \dots, \varepsilon_n} = \mathbf{P}(\varepsilon_1 S_1 > 0, \dots, \varepsilon_n S_n > 0) \quad (1.3)$$

thus

$$\forall n \geq 1; \quad \tau_n = \mathbf{m}_f^{\overbrace{-, \dots, -}^{(n-1) \text{ times}}, +}$$

and \mathbf{m}_f is the *average induced by the diffusion f* . A short explanation on this terminology is given in appendix A. The exponential law, that is, the “diffusion” $x \mapsto \frac{1}{2}e^{-|x|}$, yields an induced average \mathbf{man} than can be explicitly computed :

$$\mathbf{man}^{\varepsilon_1, \dots, \varepsilon_n} \equiv 4^{-n} ca_{n_1} ca_{n_2} \dots ca_{n_s} (1 + n_s) \quad (1.4)$$

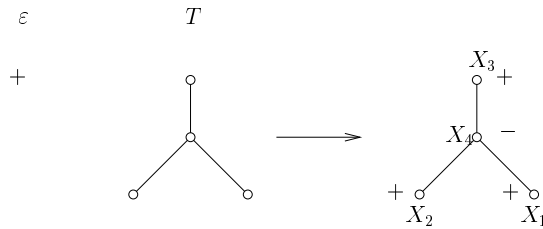
where the integers n_1, n_2, \dots, n_s denote the numbers of identical consecutive signs within the sequence $(\varepsilon_1, \dots, \varepsilon_n)$:

$$(\varepsilon_1, \dots, \varepsilon_n) = (\pm)^{n_1} (\mp)^{n_2} \dots (\varepsilon_n)^{n_s} \quad (\text{of course } n_1 + \dots + n_s = n) \quad (1.5)$$

This average is the *Catalan* average, as the classical Catalan numbers ca_n appear. This result is of course compatible with Andersen's theorem and points out that the combinatorial properties of the Catalan number could be helpful in the study of such random walks.

The Catalan numbers enumerate the ordered trees and we prove, in the first sections of this paper, that :

1. we can associate to each tree, combined with a given sign $\varepsilon = \pm$, a specific probability linked to the random walk.

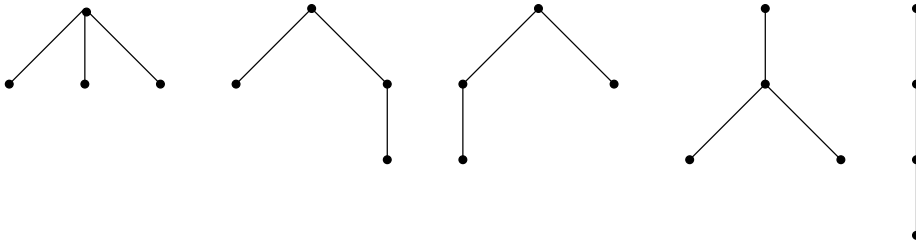


$$\mathbf{m}^{T,+} = P(+X_1 > 0, +X_2 > 0, -(X_4 + X_2 + X_1) > 0, +(X_3 + X_4 + X_2 + X_1) > 0)$$

2. For a given sequence $(\varepsilon_1, \dots, \varepsilon_n)$, we can associate a set of ordered trees \mathcal{F} such that $\mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n} = \sum_{T \in \mathcal{F}} \mathbf{m}^{T, \varepsilon_n}$. For example,

$$\mathbf{m}^{++++} = \sum_{T \in Ca_4} \mathbf{m}^{T,-}$$

where Ca_4 is the set of rooted-ordered trees with four vertices.



The set Ca_4 ($\text{Card}(Ca_4) = ca_3$).

The definitions, as well as the proofs, are enclosed in sections 2 to 7.

This tree decomposition extends the one developed in [12]. It had been discovered by considering diffusions belonging to the vector space $\text{Vect}_{\mathbf{C}}\{x \mapsto e^{-\lambda|x|}; \lambda > 0\}$. Note that such vectors, called *linear exponential diffusions*, are not necessarily probability densities. Nonetheless, every weight of an average $\mathbf{m}_f^{\varepsilon_1, \dots, \varepsilon_n}$ is an integral on a given measurable domain of \mathbf{R}^n : their definition can be extended to the case $f \in L^1(\mathbf{R})$ (see section 2). One of the most interesting properties of such diffusions is that the tree coefficients $\mathbf{m}^{T, \varepsilon}$ can be explicitly computed.

Sections 8 and 9 are devoted to applications in probability theory. We first prove Andersen's result with the help of tree decomposition. We also prove that this tree decomposition, when applied to the simple random walk, yields back the bijection between

Dyck paths and ordered trees, which underlies the well-known isomorphism between the positive excursions of the simple random walk and the geometric Galton-Watson process (see [1, 8, 13]). Further results shall be given in a forthcoming paper.

2 Averages induced by a diffusion.

We remind here some definitions for mathematical objects associated to a diffusion. Starting with an integrable function, we build a family of coefficients that are indexed by sequences of + or - signs. A complete expository on the need for such objects can be found in [3, 10, 11].

2.1 Definition.

Let us consider an integrable function f on \mathbf{R} , then,

Definition 2.1 *The **generalized average \mathbf{m}** induced by f is the collection of weights :*

$$\mathbf{m} = \{m^{\varepsilon_1, \dots, \varepsilon_n} , n \geq 1 , \varepsilon_i = \pm\} \quad (2.6)$$

With :

$$\forall n \geq 1, \forall (\varepsilon_1, \dots, \varepsilon_n) \in \{-, +\}^n \quad \mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n} = \int_{\mathbf{R}^n} \prod_{i=1}^n f(x_i) \sigma_{\varepsilon_i}(\tilde{x}_i) dx_i \quad (2.7)$$

and

$$\forall 1 \leq i \leq n, \tilde{x}_i = x_1 + \dots + x_i, \quad \sigma_{\varepsilon_i} = \mathbf{1}_{\mathbf{R}^{\varepsilon_i}}$$

Remarks

- If f is non-negative and its integral is 1, then we recover the probability sets introduced above.
- If f is even and its integral is 1 then we obtain a well-behaved average, see [3, 10, 11], which is useful in real resummation theory.
- When the integral of f is non zero, the average is very close (and trivially related) to the average induced by f *normalized* by its integral.
- If the integral of f is zero, then \mathbf{m} defines an *alien operator*, see [3, 10].
- We will use the identities $\sigma_+ + \sigma_- = Id_{\mathbf{R}}$ and $\sigma_+ \sigma_- = 0$. This is “almost sure” and the coming identities should be understood this way. That’s why we consider random walks with a probability density in $L^1(\mathbf{R})$. For an arbitrary random walk (and for the simple random walk), our results remain valid with one of the “non-symmetric” definitions :

$$\sigma_+ = \mathbf{1}_{\mathbf{R}^+} \text{ and } \sigma_- = \mathbf{1}_{\mathbf{R}^{-*}}$$

or

$$\sigma_+ = \mathbf{1}_{\mathbf{R}^{+*}} \text{ and } \sigma_- = \mathbf{1}_{\mathbf{R}^-}$$

- We can, in every case, note $\mathbf{m}^\emptyset = \int_{\mathbf{R}} f(x) dx$ and then,

$$\forall (\varepsilon_1, \dots, \varepsilon_{n-1}) \in \{-, +\}^{n-1} \quad \sum_{\varepsilon_n = \pm} \mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n} = \mathbf{m}^{\varepsilon_1, \dots, \varepsilon_{n-1}} \cdot \mathbf{m}^\emptyset$$

There is also a family of “weighted functions” induced by f :

Definition 2.2 For $n \geq 1$, and any sequence $(\varepsilon_1, \dots, \varepsilon_n)$ of plus or minus signs, one can define the weighted function $f^{\varepsilon_1, \dots, \varepsilon_n}$ by the following induction :

$$\begin{cases} f^{\varepsilon_1} &= f \cdot \sigma_{\varepsilon_1} \\ f^{\varepsilon_1, \dots, \varepsilon_n} &= (f * f^{\varepsilon_1, \dots, \varepsilon_{n-1}}) \cdot \sigma_{\varepsilon_n} \quad \text{if } n \geq 2 \end{cases} \quad (2.8)$$

and $*$ is the usual convolution in $L^1(\mathbf{R})$.

Note that for any sequence $(\varepsilon_1, \dots, \varepsilon_n)$:

$$\mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n} = \int_{\mathbf{R}} f^{\varepsilon_1, \dots, \varepsilon_n}(x) dx$$

In order to study the general averages and their weighted functions, we give some compact notations and introduce a new family of coefficients that plays a central role in the coming results.

2.2 The family M .

Let us consider first pairs in $\{+, -\} \times \mathbf{R}$, that is $\binom{\varepsilon}{x}$ ($\varepsilon = \pm, x \in \mathbf{R}$). For $n \geq 1$ and for a given sequence $\binom{\varepsilon}{\mathbf{x}} = \binom{\varepsilon_1, \dots, \varepsilon_n}{x_1, \dots, x_n}$ in $(\{+, -\} \times \mathbf{R})^n$, the previous section suggests to define the coefficient :

$$M\binom{\varepsilon}{\mathbf{x}} = M\binom{\varepsilon_1, \dots, \varepsilon_n}{x_1, \dots, x_n} = \sigma_{\varepsilon_1}(x_1)\sigma_{\varepsilon_2}(x_1 + x_2) \dots \sigma_{\varepsilon_n}(x_1 + \dots + x_n) \quad (2.9)$$

On the same way, if $\mathbf{x} = (x_1, \dots, x_n)$ is a sequence in \mathbf{R}^n , then :

$$\begin{cases} F^{\mathbf{x}} &= f(x_1) \dots f(x_n) & \|\mathbf{x}\| &= x_1 + \dots + x_n \\ d\mathbf{x} &= dx_1 \dots dx_n & l(\mathbf{x}) &= n \end{cases} \quad (2.10)$$

We can thus write that, for a given finite sequence ε of plus or minus signs,

$$\mathbf{m}^{\varepsilon} = \int_{\mathbf{x} \in \mathbf{R}^{l(\varepsilon)}} F^{\mathbf{x}} M\binom{\varepsilon}{\mathbf{x}} d\mathbf{x} \quad (2.11)$$

and, introducing the Dirac distribution δ , see definition 2.2, for a sequence $\varepsilon = (\varepsilon_1, \dots, \varepsilon_n)$ ($n \geq 1$) :

$$\forall x \in \mathbf{R}, \quad f^{\varepsilon}(x) = \int_{\mathbf{y} \in \mathbf{R}^{l(\varepsilon)}} F^{\mathbf{y}} M\binom{\varepsilon}{\mathbf{y}} \delta(x - \|\mathbf{y}\|) d\mathbf{y} \quad (2.12)$$

These representations for generalized averages and weighted functions suggest that many of their generic properties will stem from the study of the family M . This is the case for their *Tree-decomposition* formulas.

3 Ordered trees and forests.

We follow the terminology given in [15].

3.1 Ordered trees.

Ordered trees may be defined recursively as follows : An *ordered* (or *plane*) *tree* is a finite set of *vertices* such that :

- (a) One specially designated vertex is called the root and
- (b) the remaining vertices (excluding the root) are put in an ordered partition (T_1, \dots, T_m) of $m \geq 0$ disjoint non-empty sets T_1, \dots, T_m , each of which is an ordered tree. The trees T_1, \dots, T_m are called *subtrees*.

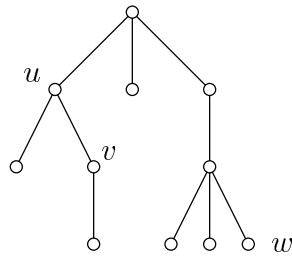
Of course, a tree is also a graph, considering that, in the recursive definition, we can put edges between the root and the roots of the subtrees. The *size* of a tree is the number of its vertices. Note that a tree of size n has exactly $n - 1$ edges. For $n \geq 1$, Ca_n is the set of ordered trees of size n , and we note ca_{n-1} its cardinal. This notation is natural as the numbers ca_n are the Catalan numbers :

$$ca_n = \frac{1}{n+1} \binom{2n}{n} = \frac{(2n)!}{(n+1)!n!} \quad (3.13)$$

We assume that the definitions of the son (or successor) of a vertex, the father (or predecessor) of a vertex, as well as the notion of leafs (or endpoints), are obviously illustrated by the following figure.



u is the father of v
 v is the son of u
 w is a leaf.

3.2 Forests.

A forest F is a sequence T_1, \dots, T_m ($m \geq 1$) of ordered trees. Its size is the sum of the sizes of its ordered trees. For $n \geq 1$, Fa_n is the set of forests of size n and its cardinal is ca_n . In fact, there is an obvious bijection between Fa_n and Ca_{n+1} . One can transform a forest into an ordered tree by adding a common root to the sequence of trees composing the forest. Reciprocally, cutting the root of an ordered tree gives rise to a forest. Let us give the first sets of forests and suggest by dotted lines the corresponding ordered trees :

$n = 1$	
$n = 2$	
$n = 3$	

Figure 2: First sets Fa_n of forests

Let us make some final remarks on the terminology for a forest $F (= (T_1, \dots, T_m))$:

- For any vertex v in F , we note $\rho(v)$ the root of the ordered tree containing this vertex. Thus, $\rho(F)$ is the root set of the forest F .
- The *height* $h(v)$ of a vertex v is the number of edges between v and its root $\rho(v)$.
- The forest F naturally defines a partial order \succ_F on the set of its vertices. For two vertices u and v , $u \succ_F v$ means that v belongs to the subtree having u as root. For

example, the set of vertices has a maximal element iff F contains only one tree. In this case, the maximal element is the unique root of F .

4 The tree-indexed family.

We define a family of coefficients similar to the family M (see section 2.2) but indexed by a tree structure. To do so, we first give a way to label a tree or a forest by a sequence of variables.

4.1 Labeled trees and forests.

For $n \geq 1$, consider F a forest of size n and (x_1, \dots, x_n) a sequence of variables. A *labeling* of F by the sequence (x_1, \dots, x_n) is a bijection ϕ between the set of vertices of F and $\{x_1, \dots, x_n\}$. For a given labeling ϕ , one defines the “beginning sums” of variables associated to F and ϕ :

$$\forall 1 \leq j \leq n; \quad \check{x}_j = \sum_{\phi^{-1}(x_j) \succeq_F u} \phi(u) \quad (4.14)$$

For example :

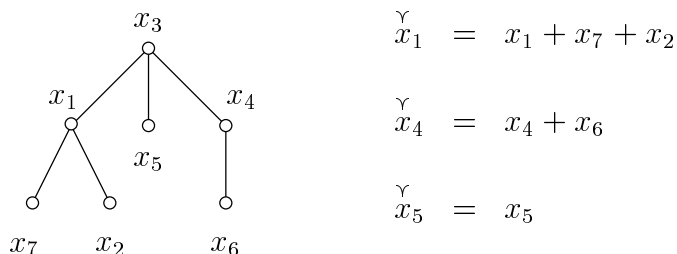


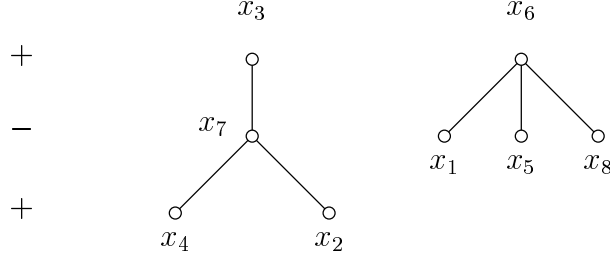
Figure 3: Some beginning sums for a given labeling.

4.2 Tree coefficients.

Definition 4.3 Let F be a forest of size n , ϕ a labeling of F by the sequence of variables $(x_1, \dots, x_n) = \mathbf{x}$, for a given plus or minus sign ε , we define the coefficient

$$M_{F,\phi}^{\varepsilon,\mathbf{x}} = \prod_{u \in F} \sigma_{\varepsilon(-1)^{h(u)}} \left(\phi(u) \right) \quad (4.15)$$

$$F, \phi, \varepsilon = +$$



Let us give an illustration of this definition :

$$\begin{aligned}
 M_{F,\phi}^{\varepsilon,\mathbf{x}} &= \sigma_+(x_3 + x_7 + x_4 + x_2)\sigma_-(x_7 + x_4 + x_2)\sigma_+(x_2)\sigma_+(x_4) \\
 &\quad \times \sigma_+(x_6 + x_1 + x_5 + x_8)\sigma_-(x_1)\sigma_-(x_5)\sigma_-(x_8)
 \end{aligned}$$

A noticeable fact is that, if the forest F is composed of several trees (T_1, \dots, T_m) ($m \geq 2$), then a labeling ϕ of F by the sequence $\mathbf{x} = (x_1, \dots, x_n)$ induces for each tree T_i a unique labeling ϕ_i by a subsequence \mathbf{x}^i of \mathbf{x} . Thus,

$$\begin{aligned}
 M_{F,\phi}^{\varepsilon,\mathbf{x}} &= \prod_{u \in F} \sigma_{\varepsilon(-1)^{h(u)}} \left(\phi^{\succ}(u) \right) \\
 &= \prod_{\rho \in \rho(F)} \prod_{\rho \succ_F u} \sigma_{\varepsilon(-1)^{h(u)}} \left(\phi^{\succ}(u) \right) \\
 &= \prod_{i=1}^m M_{T_i, \phi_i}^{\varepsilon, \mathbf{x}^i}
 \end{aligned} \tag{4.16}$$

This results is illustrated by the previous figure and there is no ambiguity on the ordering and the beginning sums : The restriction of \succ to the set of vertices of a tree T_i is precisely \succ_{T_i} .

We shall be able now to relate these coefficients to the initial family M (see section 2.2).

5 Tree decomposition for the family M .

5.1 Some specific labeled forests \mathcal{F} .

For a *bisequence* $\binom{\varepsilon}{\mathbf{x}} = \binom{\varepsilon_1, \dots, \varepsilon_n}{x_1, \dots, x_n}$ in $(\{+, -\} \times \mathbf{R})^n$ ($n \geq 1$), we give the inductive definition of a set $\mathcal{F}^{\binom{\varepsilon}{\mathbf{x}}}$ that corresponds to a set of forests of size n , each of them having a given

labeling ϕ_F by the sequence (x_1, \dots, x_n) .

If $\underline{n = 1}$, $\mathcal{F}^{(\varepsilon_1)}_{(x_1)}$ is the unique forest of size 1, with its trivial labeling by x_1 (There is only one vertex to be labeled by x_1).

If $\underline{n \geq 2}$, Consider first the set $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_{n-1})}_{(x_1, \dots, x_{n-1})}$.

- If $\varepsilon_n \neq \varepsilon_{n-1}$, the elements (F, ϕ_F) of $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_n)}_{(x_1, \dots, x_n)}$ are obtained by the following transformation. Pick an element $(F', \phi_{F'})$ of $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_{n-1})}_{(x_1, \dots, x_{n-1})}$ and consider F' as the sequence of subtrees of a rooted tree with its root labeled by x_n . This gives birth to a forest of size n (with only one tree), and its labeling by the sequence (x_1, \dots, x_n) is naturally induced.
- If $\varepsilon_n = \varepsilon_{n-1}$ then, once again, consider first an element $(F', \phi_{F'})$ of $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_{n-1})}_{(x_1, \dots, x_{n-1})}$. We shall now give several ways to add a new vertex labeled by x_n . We remind that F' is composed of trees (T_1, \dots, T_m) ($m \geq 1$). We do either of the following transformations to get an element of $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_n)}_{(x_1, \dots, x_n)}$.
 1. Add the unique tree of size 1, labeled by x_n , to the sequence (T_1, \dots, T_m) , on its right.
 2. For $1 \leq i \leq m$, add the vertex labeled by x_n as the rightest son of the root of T_i and consider then (T_{i+1}, \dots, T_m) as subtrees of the vertex labeled by x_n .

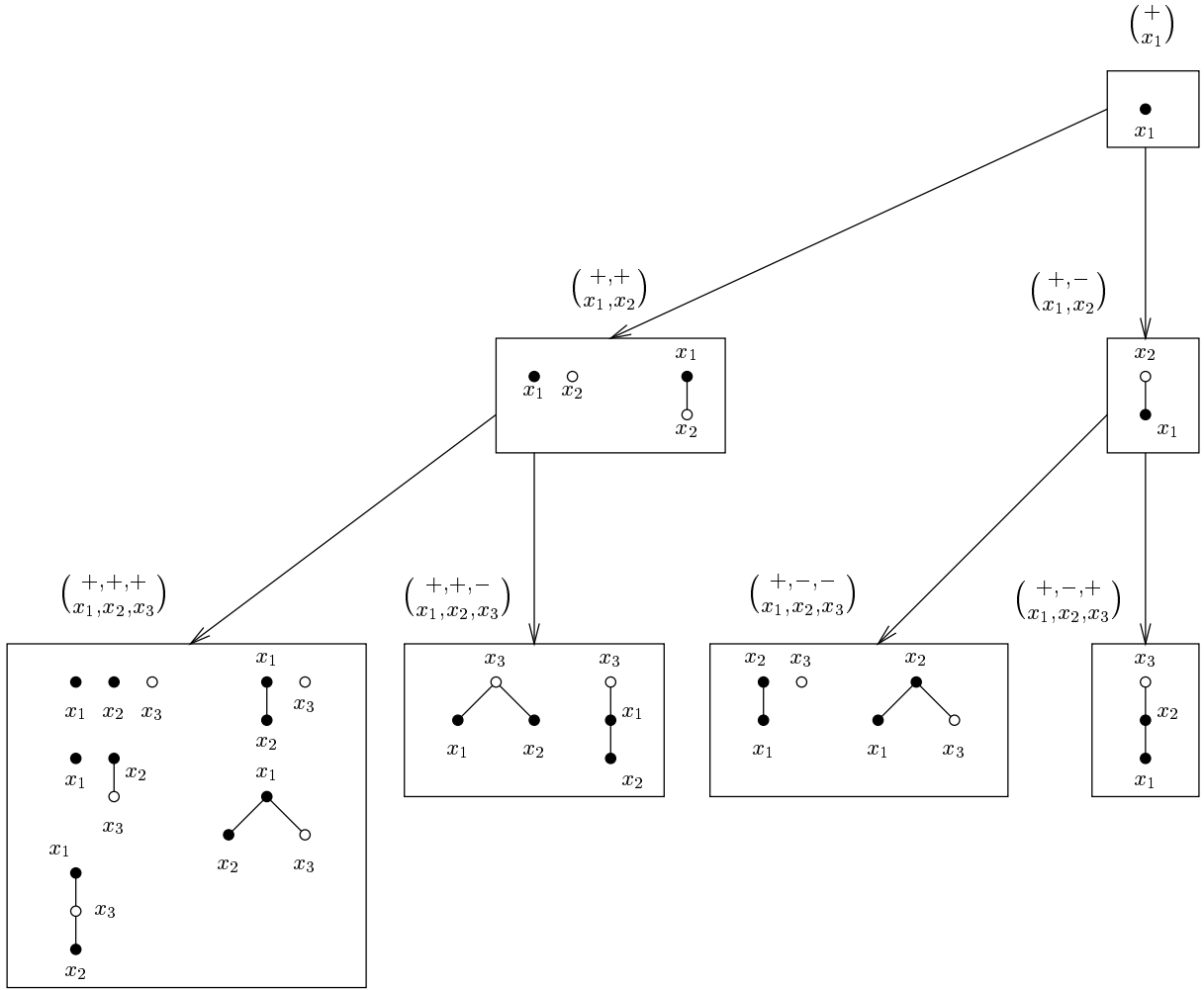


Figure 4: First labeled forests.

These operations are illustrated on figure 4.

In every case, for $n \geq 2$, starting with an element (F, ϕ) of $\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_{n-1})}_{(x_1, \dots, x_{n-1})}$ the above construction yields a set of forests labeled by $(x_1, \dots, x_n) : S_{\varepsilon_{n-1}, \varepsilon_n}^{x_n}(F, \phi)$ and

$$\mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_n)}_{(x_1, \dots, x_n)} = \bigcup_{(F, \phi) \in \mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_{n-1})}_{(x_1, \dots, x_{n-1})}} S_{\varepsilon_{n-1}, \varepsilon_n}^{x_n}(F, \phi) \quad (5.17)$$

Moreover, one easily check that there is no repetition of the same tree (independently of the labeling) in such sets.

This rather obscure construction becomes natural in the results on tree decomposition for the family M .

5.2 Main theorem.

Theorem 5.1 For a bisequence $\binom{\varepsilon}{\mathbf{x}} = (\varepsilon_1, \dots, \varepsilon_n)$ in $(\{+, -\} \times \mathbf{R})^n$ ($n \geq 1$),

$$M^{(\varepsilon_1, \dots, \varepsilon_n)}_{(x_1, \dots, x_n)} = \sum_{(F, \phi_F) \in \mathcal{F}^{(\varepsilon_1, \dots, \varepsilon_n)}_{(x_1, \dots, x_n)}} M_{F, \phi_F}^{\varepsilon_n, \mathbf{x}} \quad (5.18)$$

Sketch of the proof : It can be proved by induction that the sets \mathcal{F} are the right ones. For $n \geq 2$, thanks to the definition of the family M (eq. 2.9) :

$$M^{(\varepsilon)} = M^{(\varepsilon_1, \dots, \varepsilon_n)} = M^{(\varepsilon_1, \dots, \varepsilon_{n-1})} \sigma_{\varepsilon_n} (x_1 + \dots + x_n) \quad (5.19)$$

This identity can then be combined with the following result :

For $\varepsilon = \pm$ and (y_1, \dots, y_m, z) some real variables ($m \geq 1$) :

$$\begin{aligned}
& \sigma_\varepsilon(y_1)\sigma_\varepsilon(y_2)\dots\sigma_\varepsilon(y_m)\sigma_\varepsilon(y_1+\dots+y_m+z) = \\
& \sigma_\varepsilon(y_1)\sigma_\varepsilon(y_2)\dots\sigma_\varepsilon(y_m)\sigma_\varepsilon(z) + \\
& \sum_{i=1}^r \left(\begin{array}{l} \sigma_\varepsilon(y_1)\dots\sigma_\varepsilon(y_{i-1})\sigma_\varepsilon(y_i+\dots+y_m+z) \\ \times \sigma_\varepsilon(y_{i+1}+\dots+y_m+z)\sigma_\varepsilon(y_{i+1})\dots\sigma_\varepsilon(y_m) \end{array} \right)
\end{aligned} \tag{5.20}$$

Using this property and eq. (5.19) : For $n \geq 1$, let F be a forest of size n and ϕ a given labeling by $\mathbf{x}^n = (x_1, \dots, x_n)$, then, for $\varepsilon = \pm$, $\eta = \pm$ and $\mathbf{x}^{n+1} = (x_1, \dots, x_{n+1})$, we get (see also eq. (4.16)) :

$$M_{F,\phi}^{\varepsilon,\mathbf{x}^n} \sigma_\eta(x_1 + \dots + x_{n+1}) = \sum_{(G,\gamma) \in \mathcal{S}_{\varepsilon,\eta}^{\mathbf{x}^{n+1}}(F,\phi)} M_{G,\gamma}^{\eta,\mathbf{x}^{n+1}} \tag{5.21}$$

It becomes obvious that the sets \mathcal{F} were build on purpose. We leave to the reader the complete proof for equations (5.20) and (5.21), but the following illustrations should be convincing.

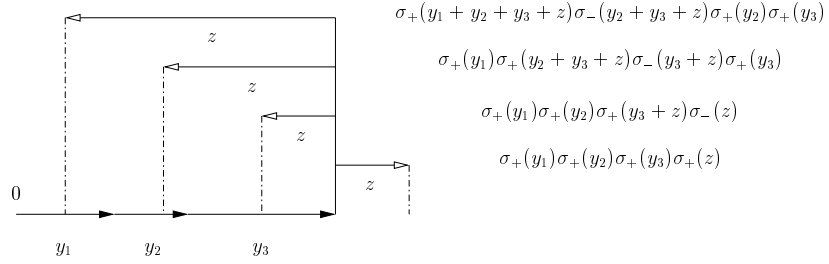


Figure 5: Eq. (5.20) for $\sigma_+(y_1)\sigma_+(y_2)\sigma_+(y_3)\sigma_+(y_1+y_2+y_3+z)$.

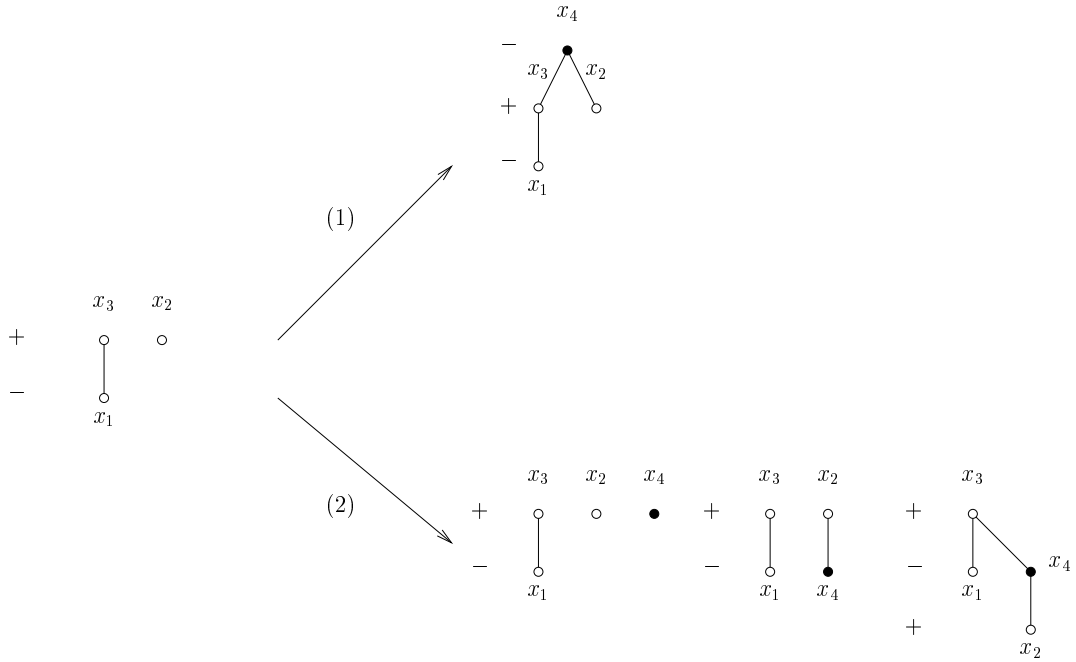


Figure 6: Illustration for Eq. (5.21)

Equation (5.21) is illustrated by the figure 6. We start from the coefficient :

$$M_{F,\phi}^{+,x_1,x_2,x_3} = \sigma_-(x_1)\sigma_+(x_3+x_1)\sigma_+(x_2)$$

The arrow (1) is the multiplication by $\sigma_-(x_1+x_2+x_3+x_4)$ and the underlying tree construction is obvious. The second arrow (2) is the multiplication by $\sigma_+(x_1+x_2+x_3+x_4)$ and, thanks to equation (5.20) ($y_1 = x_3+x_1, y_2 = x_2, z = x_4$) :

$$\begin{aligned}
& \sigma_+(x_3+x_1)\sigma_+(x_2)\sigma_+(x_3+x_1+x_2+x_4) = \\
& \sigma_+(x_3+x_1)\sigma_+(x_2)\sigma_+(x_4) \\
& + \sigma_+(x_3+x_1)\sigma_+(x_2+x_4)\sigma_-(x_4) \\
& + \sigma_+(x_3+x_1+x_2+x_4)\sigma_-(x_2+x_4)\sigma_+(x_2)
\end{aligned}$$

and the tree construction is now obvious.

In the following section we give some combinatorial properties of the family of forests.

We will then examine the consequences of theorem 5.1 for generalized averages and weighted functions (see section 2).

6 Some combinatorial properties of sets of forests \mathcal{F} .

Let us consider, as in section 5.1, a set $\mathcal{F}(\frac{\varepsilon}{\mathbf{x}})$, with $(\frac{\varepsilon}{\mathbf{x}}) = (\frac{\varepsilon_1, \dots, \varepsilon_n}{x_1, \dots, x_n})$ in $(\{+, -\} \times \mathbf{R})^n$ ($n \geq 1$). This is a set of labeled forests, and, once the labeling is omitted, it remains a set of forests of size n . This set depends only on the consecutive stacks of identical signs. We note these sets $\mathcal{F}_{n_1, \dots, n_s}$ if $\varepsilon = (\pm)^{n_1} (\mp)^{n_2} \dots (\varepsilon_n)^{n_s}$. Let us give some combinatorial results on these sets of forests.

6.1 Enumeration.

For a sequence n_1, \dots, n_s ($s \geq 1, n_i \geq 1$) :

$$\text{Card}(\mathcal{F}_{n_1, \dots, n_s}) = ca_{n_1} \dots ca_{n_s} \quad (6.22)$$

Moreover, a forest in $\mathcal{F}_{n_1, \dots, n_s}$ has at most n_s trees and if, for $1 \leq k \leq n_s$, $\mathcal{F}_{n_1, \dots, n_s}^k$ is the subset of forests of $\mathcal{F}_{n_1, \dots, n_s}$ having k trees, then :

$$\text{Card}(\mathcal{F}_{n_1, \dots, n_s}^k) = ca_{n_1} \dots ca_{n_{s-1}} \frac{k}{2n_s - k} \binom{2n_s - k}{n_s} \quad (6.23)$$

This also means that, for $n \geq 1$:

$$\sum_{k=1}^n \frac{k}{2n-k} \binom{2n-k}{n} = ca_n \quad (6.24)$$

The reader shall convince himself on figure 4.

6.2 Construction.

All these sets were defined in section 5.1. Nonetheless, we give an equivalent construction of the sets $\mathcal{F}_{n_1, \dots, n_s}$ by induction on s ($n_1 \geq 1, \dots, n_s \geq 1$).

- If $s = 1$ then \mathcal{F}_{n_1} is the complete set of forests of size n_1 (see section 3.2) :

$$\mathcal{F}_{n_1} = Fa_{n_1}$$

- If $s \geq 2$ then consider the sets $\mathcal{F}_{n_1, \dots, n_{s-1}}$ and Fa_{n_s} . The elements of $\mathcal{F}_{n_1, \dots, n_s}$ are the forests obtained by considering now an element of $\mathcal{F}_{n_1, \dots, n_{s-1}}$ as supplementary (and to its left) subtrees of the leftest root of an element of Fa_{n_s} .

Note that this construction yields a part of the proof for the enumeration results.

7 Application to generalized averages.

Let us first remind, see section 2, that, once an integrable function f is given, the family M plays a central role in the definition of :

- **Generalized average** (see eq. (2.11)) :

$$\mathbf{m}^\varepsilon = \int_{\mathbf{x} \in \mathbf{R}^{l(\varepsilon)}} f(x_1) \dots f(x_n) M^{\binom{\varepsilon}{\mathbf{x}}} d\mathbf{x}$$

- **Weighted functions** (see eq. (2.12)) :

$$\forall y \in \mathbf{R}, \quad f^\varepsilon(y) = \int_{\mathbf{x} \in \mathbf{R}^{l(\varepsilon)}} f(x_1) \dots f(x_n) M^{\binom{\varepsilon}{\mathbf{x}}} \delta(y - \|\mathbf{x}\|) d\mathbf{x}$$

Assuming that, as in equation (2.10), $\varepsilon = (\varepsilon_1, \dots, \varepsilon_n) \in \{+, -\}^n$, $l(\varepsilon) = n$ and, in addition, $\mathbf{x} = (x_1, \dots, x_n) \in \mathbf{R}^n$ and $\|\mathbf{x}\| = x_1 + \dots + x_n$.

7.1 More Tree coefficients and Tree functions.

Definition 7.4 For a forest F of size n , a labeling ϕ of F by $\mathbf{x} = (x_1, \dots, x_n)$, and a given sign $\varepsilon = \pm$, let us define :

$$\mathbf{m}_\phi^{F,\varepsilon} = \int_{\mathbf{x} \in \mathbf{R}^n} f(x_1) \dots f(x_n) M_{F,\phi}^{\varepsilon,\mathbf{x}} d\mathbf{x} \quad (7.25)$$

and

$$\forall y \in \mathbf{R}, \quad f_\phi^{F,\varepsilon}(y) = \int_{\mathbf{x} \in \mathbf{R}^n} f(x_1) \dots f(x_n) M_{F,\phi}^{\varepsilon,\mathbf{x}} \delta(y - \|\mathbf{x}\|) d\mathbf{x} \quad (7.26)$$

Here are two noticeable facts on these coefficients :

1. Except for the tree coefficient $M_{F,\phi}^{\varepsilon,\mathbf{x}}$, the integrated function is symmetric : the previous coefficients *do not* depend on the labeling :

$$\mathbf{m}_\phi^{F,\varepsilon} = \mathbf{m}^{F,\varepsilon}$$

$$f_\phi^{F,\varepsilon} = f^{F,\varepsilon}$$

2. If F is a forest composed of k trees $F = (T_1, \dots, T_k)$, then :

$$\mathbf{m}^{F,\varepsilon} = \mathbf{m}^{T_1,\varepsilon} \cdot \mathbf{m}^{T_2,\varepsilon} \dots \mathbf{m}^{T_k,\varepsilon}$$

$$f^{F,\varepsilon} = f^{T_1,\varepsilon} * f^{T_2,\varepsilon} * \dots * f^{T_k,\varepsilon}$$

These results point out that the coefficients corresponding to single trees should be the most important. Let us give now the conclusion of the previous work.

7.2 Tree decomposition for generalized averages and weighted functions.

Let us remind that, for a sequence $\varepsilon \in \{+, -\}^n$ also written $\varepsilon = (\pm)^{n_1} (\mp)^{n_2} \dots (\varepsilon_n)^{n_s}$, we defined in the previous sections a set of forests \mathcal{F}^ε that corresponds either to the forests involved in $\mathcal{F}^{(\varepsilon)}$ (section 5) or to $\mathcal{F}_{n_1, \dots, n_s}$ (section 6). Combining now the previous results :

Theorem 7.2 For $n \geq 1$ and $\varepsilon = (\varepsilon_1, \dots, \varepsilon_n) \in \{+, -\}^n$, the set of forests $\mathcal{F}^\varepsilon \subset Fa_n$ is such that :

$$\mathbf{m}^\varepsilon = \sum_{F \in \mathcal{F}^\varepsilon} \mathbf{m}^{F,\varepsilon_n} \quad (7.27)$$

and

$$\forall y \in \mathbf{R}, \quad f^\varepsilon(y) = \sum_{F \in \mathcal{F}^\varepsilon} f^{F,\varepsilon_n}(y) \quad (7.28)$$

Here comes a first application of the tree decomposition : a proof for Andersen's formula.

8 Back to Andersen's formula.

8.1 The free associative algebra $\mathbf{Z}\langle\mathcal{T}\rangle$.

The set of ordered trees $\mathcal{T} = \{T \in Ca_n ; n \geq 1\}$ can be considered as a set of noncommuting variables, the multiplication being the concatenation. It generates the free associative \mathbf{Z} -algebra $\mathbf{Z}\langle\mathcal{T}\rangle$ (see [9, 14]) with a natural graduation given by the number of vertices in a tree. As any forest of $\mathcal{F} = \{F \in Fa_n ; n \geq 1\}$ is easily identified to a concatenation of trees, $\mathbf{Z}\langle\mathcal{T}\rangle = \mathbf{Z}\langle\mathcal{F}\rangle$. We can also identify some sets to the sum of their elements :

For $n \geq 1$,

$$Ca_n = \sum_{T \in Ca_n} T \quad (8.29)$$

$$Fa_n = \sum_{F \in Fa_n} F = \sum_{\substack{n_1 + \dots + n_s = n \\ s \geq 1 ; n_i \geq 1}} \sum_{\substack{T_i \in Ca_{n_i} \\ 1 \leq i \leq s}} T_1 \dots T_s = \sum_{\substack{n_1 + \dots + n_s = n \\ s \geq 1 ; n_i \geq 1}} Ca_{n_1} \cdot Ca_{n_2} \dots Ca_{n_s} \quad (8.30)$$

8.2 An operator on $\mathbf{Z}\langle\mathcal{T}\rangle$.

Section 6 suggests to introduce the operator LA that is called the ‘‘Left Attachment’’. It is a bilinear morphism from $\mathbf{Z}\langle\mathcal{T}\rangle \times \mathbf{Z}\langle\mathcal{T}\rangle$ to $\mathbf{Z}\langle\mathcal{T}\rangle$ and it can be defined on a pair of forests : Let F_1, F_2 be two forests, we can ‘‘add’’ F_1 to the forest F_2 by considering F_1 as supplementary (and to its left) subtrees of the leftest root of F_2 . The resulting forest is the Left Attachment of F_1 to F_2 : $LA(F_1, F_2)$.

We have the following identities, if $F_1 = T_1^1 \dots T_t^1$ and $F_2 = T_1^2, \dots, T_s^2$ then :

$$LA(F_1, T_1^2 \dots T_s^2) = LA(F_1, T_1^2) T_2^2 \dots T_s^2 \quad (8.31)$$

$$LA(T_1^1 \dots T_t^1, F_2) = LA(T_1^1, LA(T_2^1, LA(\dots, LA(T_{t-1}^1, LA(T_t^1, F_2)) \dots))) \quad (8.32)$$

Let us end this section with a combinatorial result :

Lemma 8.1 For $n \geq 2$,

$$\sum_{\substack{n_1 + \dots + n_s = n \\ s \geq 2}} n_{s-1} LA(Ca_{n_1} \dots Ca_{n_{s-1}}, Ca_{n_s}) = (n-1)Ca_n \quad (8.33)$$

The proof is straightforward. Consider a tree T in Ca_n , it can be decomposed : on one side there is the root, on the other side, there is the forest of subtrees $T' = F$ which belongs to Fa_{n-1} . There exists a unique composition (m_1, \dots, m_t) of $n-1$ ($m_1 + \dots + m_t = n-1$) such that $F \in Ca_{m_1} \dots Ca_{m_t}$, thus $F = T_1 \dots T_t$. Note that we just remind here that there is a natural bijection between Ca_n and Fa_{n-1} . For $1 \leq i \leq t$, consider T^i the tree of $Ca_{n-(m_1+\dots+m_i)}$ obtained by omitting $T_1 \dots T_i$ in T :

$$T = LA(T_1 \dots T_i, T^i)$$

and

$$(n-1)T = (m_1 + \dots + m_t)T = \sum_{i=1}^t m_i LA(T_1 \dots T_i, T^i)$$

But if we note $r(F)$ the tree such that $r(F)' = F$ ($r(\emptyset) = \bullet$), then :

$$\begin{aligned} (n-1)Ca_n &= \sum_{T \in Ca_n} (n-1)T \\ &= \sum_{n_1 + \dots + n_s = n-1} \sum_{F \in Ca_{n_1} \dots Ca_{n_s}} (n-1)r(F) \\ &= \sum_{n_1 + \dots + n_s = n-1} \sum_{\substack{T_k \in Ca_{n_k} \\ 1 \leq k \leq s}} (n_1 + \dots + n_s)r(T_1 \dots T_s) \\ &= \sum_{n_1 + \dots + n_s = n-1} \sum_{\substack{T_k \in Ca_{n_k} \\ 1 \leq k \leq s}} \sum_{i=1}^s n_i LA(T_1 \dots T_i, r(T_{i+1} \dots T_s)) \\ &= \sum_{i=1}^{n-1} \sum_{n_1 + \dots + n_i + m = n} n_i LA(Ca_{n_1} \dots Ca_{n_i}, Ca_m) \end{aligned}$$

This is the attempted result.

Thanks to section 6, Andersen's formula is a corollary of this lemma.

8.3 A proof of Andersen's formula.

We remind that, to any sequence (n_1, \dots, n_s) of positive integers, a set of forest is associated by :

$$\mathcal{F}_{n_1, \dots, n_s} = \begin{cases} Fa_{n_1} & \text{if } s = 1 \\ LA(\mathcal{F}_{n_1, \dots, n_{s-1}}, Fa_{n_s}) & \text{if } s \geq 2 \end{cases}$$

We also define a similar family by

$$\tilde{\mathcal{F}}_{n_1, \dots, n_s} = \begin{cases} Fa_{n_1} & \text{if } s = 1 \\ LA(\sigma(\tilde{\mathcal{F}}_{n_1, \dots, n_{s-1}}), Fa_{n_s}) & \text{if } s \geq 2 \end{cases}$$

where $\sigma(F) = \sigma(T_1 \dots T_k) = T_k \dots T_1$. The first family is useful as, for a given sequence (n_1, \dots, n_s) :

$$\mathbf{m}_f^{(\pm)^{n_1}(\mp)^{n_2} \dots (\varepsilon)^{n_s}} = \sum_{F \in \mathcal{F}_{n_1, \dots, n_s}} \mathbf{m}_f^{F, \varepsilon}$$

Because of the definition of the tree coefficients, one also gets :

$$\mathbf{m}_f^{(\pm)^{n_1}(\mp)^{n_2} \dots (\varepsilon)^{n_s}} = \sum_{F \in \tilde{\mathcal{F}}_{n_1, \dots, n_s}} \mathbf{m}_f^{F, \varepsilon}$$

and these sets inherit some combinatorial properties from the previous lemma :

For $n \geq 1$

$$\sum_{n_1+\dots+n_s=n} \tilde{\mathcal{F}}_{n_1,\dots,n_s} = \sum_{l_1+\dots+l_t=n} l_1 C a_{l_1} \dots C a_{l_t} \quad (8.34)$$

Let us give the proof by induction. This result is obviously true for $n = 1$. Let $n \geq 2$ and suppose that the equation holds for $1 \leq k < n$.

$$\begin{aligned} \sum_{n_1+\dots+n_s=n} \tilde{\mathcal{F}}_{n_1,\dots,n_s} &= \tilde{\mathcal{F}}_n + \sum_{\substack{n_1+\dots+n_s=n \\ s \geq 2}} \tilde{\mathcal{F}}_{n_1,\dots,n_s} \\ &= F a_n + \sum_{\substack{n_1+\dots+n_s=n \\ s \geq 2}} LA(\sigma(\tilde{\mathcal{F}}_{n_1,\dots,n_{s-1}}), F a_{n_s}) \\ &= F a_n + \sum_{k=1}^{n-1} LA \left(\sigma \left(\sum_{\substack{m_1+\dots+m_{s'}=n-k \\ s' \geq 1}} \tilde{\mathcal{F}}_{m_1,\dots,m_{s'}} \right), F a_k \right) \\ &= F a_n + \sum_{k=1}^{n-1} \sum_{\substack{l_1+\dots+l_t=n-k \\ k_1+\dots+k_u=k}} LA(l_t C a_{l_1} \dots C a_{l_t}, C a_{k_1} \dots C a_{k_u}) \\ &= F a_n + \sum_{k=1}^{n-1} \sum_{\substack{l_1+\dots+l_t=n-k \\ k_1+\dots+k_u=k}} LA(l_t C a_{l_1} \dots C a_{l_t}, C a_{k_1}) C a_{k_2} \dots C a_{k_u} \\ &= F a_n + \sum_{k'=0}^{n-1} \sum_{k'_1+\dots+k'_u=k'} (n-k'-1) C a_{n-k'} C a_{k'_1} \dots C a_{k'_u} \\ &= \sum_{l_1+\dots+l_t=n} C a_{l_1} \dots C a_{l_t} + \sum_{l_1+\dots+l_t=n} (l_1-1) C a_{l_1} \dots C a_{l_t} \\ &= \sum_{l_1+\dots+l_t=n} l_1 C a_{l_1} \dots C a_{l_t} \end{aligned}$$

and this ends the proof.

Let us remember that

$$\forall n \geq 1 \quad ; \quad \tau_n = \overbrace{\mathbf{m}_f^-, \dots, \mathbf{m}_f^-}^{(n-1) \text{ times}}, \mathbf{m}_f^+ = \sum_{T \in C a_n} \mathbf{m}_f^{T,+}$$

As $F \mapsto \mathbf{m}_f^{F,+}$ defines a morphism from $\mathbf{Z}\langle \mathcal{T} \rangle$ to \mathbf{R} , the equation (8.34) reads :

$$\begin{aligned} \sum_{l_1+\dots+l_t=n} l_1 \tau_{l_1} \dots \tau_{l_t} &= \sum_{n_1+\dots+n_s=n} \sum_{F \in \tilde{\mathcal{F}}_{n_1,\dots,n_s}} \mathbf{m}_f^{F,+} \\ &= \sum_{\varepsilon_i = \pm ; 1 \leq i \leq n-1} \mathbf{m}_f^{\varepsilon_1 \dots \varepsilon_{n-1} +} \end{aligned}$$

If f is a probability density, then the last term is $P(S_n > 0)$ for the associated random walk and from this relation, we get, if $\tau(s) = \sum_{n=1}^{+\infty} \tau_n s^n$,

$$\frac{\tau'(s)}{1 - \tau(s)} = \sum_{n=1}^{+\infty} s^{n-1} P(S_n > 0)$$

We have proved Andersen's formula :

$$\log \frac{1}{1 - \tau(s)} = \sum_{n=1}^{+\infty} \frac{s^n}{n} P(S_n > 0) \quad (8.35)$$

Note that, if we don't care about probability, we have a similar equation for generalized averages, as soon as f is an integrable function.

9 Trees and excursion for the simple random walk.

9.1 Introduction

“Trees” and “random walk” are words that are already associated in the probability literature. We can cite the bijection between the Galton-Watson process and the excursions of the simple random walk, see [1, 8, 13]. This result is based on a combinatorial bijection between Dyck paths and ordered trees.

We shall here focus on this combinatorial approach and prove that our tree-decomposition gives back this results. The main point is that our decomposition is a generalization of this result : it establishes a bijection between labeled trees and “sets of paths”. Note that this relation seems to differ from the one that can be found in [1].

Let us first remind the bijection between Dyck paths and ordered trees.

9.2 Paths and trees.

Definition 9.5 *A Dyck path of length $2n$ ($n \in \mathbf{N}^*$) is a positive path with jumps $+1$ or -1 starting at 0 and finishing at 0 for the $2n^{\text{th}}$ jump. We note D_n the set of Dyck paths of length $2n$.*

Proposition 9.1 *For $n \geq 1$, the set of ordered trees of size n and the set of Dyck paths of length $2n$ have the same cardinal.*

This is a very classical result and from a given bijection between these two kind of sets, one can deduce the usual isomorphism between excursions of the simple random walk and the geometric Galton-Watson process.

For $n \geq 1$, the natural bijection Ψ_n between D_n and Ca_n can be defined by induction. For $n = 1$, the unique Dyck path of size 2 is associated to the unique tree of size 1. For $n \geq 2$, the bijection is defined as follows :

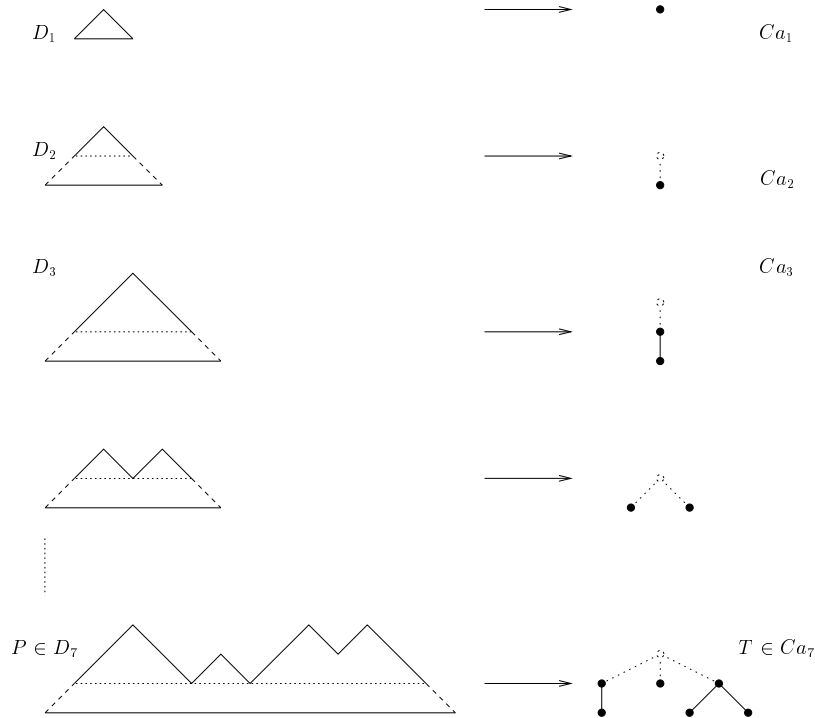


Figure 7: Inductive definition of the bijection.

Consider a Dyck path P of size $2n$, omit the first and the last jump and consider that this new path starts at the origin. This new path P' is of length $2n - 2$, is finishing at 0 and is non negative : it is a concatenation of $s \geq 1$ Dyck paths P_1, \dots, P_s of size $2n_1, \dots, 2n_s$ ($n_1 + \dots + n_s = n - 1$). Using the induction, each of the paths P_i corresponds to a unique tree T_i of Ca_{n_i} . The tree of Ca_n that is associated to P is the tree obtained by adding a common root to the ordered forest (T_1, \dots, T_s) . The construction of the inverse map is obvious. The figure 7 illustrates this construction.

We prove in the following section that this bijection can be seen as a particular case of our tree-decomposition. To do so, we first define a generalization of Dyck paths.

9.3 Generalized Dyck paths.

A path of length n is simply a sequence of coordinates $((0, 0), (1, y_1), \dots, (n, y_n))$ or, equivalently, a sequence of “jumps” (x_1, x_2, \dots, x_n) (with $y_i = \tilde{x}_i = x_1 + \dots + x_i$, for $1 \leq i \leq n$). For example, Dyck paths are paths with only $+1$ or -1 jumps.

Definition 9.6 A *generalized Dyck path (GDP)* of length n ($n \geq 1$) is a path, with real jumps, such that :

$$y_n = \tilde{x}_n = x_1 + \dots + x_n \leq 0$$

and, if $n \geq 2$,

$$\forall 1 \leq i \leq n-1, y_i = \tilde{x}_i = x_1 + \dots + x_i > 0$$

Dyck paths of length $2n$ are GDP of length $2n$, and, if GD_n stands for GDP of length n , then considering paths as sequences of jumps, the set GD_n can easily be expressed in term of the family M (see section 2.2) :

$$GD_n = \left\{ (x_1, \dots, x_n) \in \mathbf{R}^n ; M^{\overbrace{(+, \dots, +, -)}^{n-1}}_{(x_1, \dots, x_{n-1}, x_n)} = 1 \right\} \quad (9.36)$$

with

$$M^{\binom{\varepsilon_1, \dots, \varepsilon_n}{x_1, \dots, x_n}} = \sigma_{\varepsilon_1}(x_1) \sigma_{\varepsilon_2}(x_1 + x_2) \dots \sigma_{\varepsilon_n}(x_1 + \dots + x_n)$$

and

$$\sigma_+ = \mathbf{1}_{\mathbf{R}^{+*}} \quad \text{and} \quad \sigma_- = \mathbf{1}_{\mathbf{R}^-}$$

Note that

$$\forall n \geq 1 ; GD_n \cap \{+1, -1\}^n = \begin{cases} D_{n/2} & \text{if } n \text{ is even} \\ \emptyset & \text{if } n \text{ is odd} \end{cases}$$

We described in the first section the well-known bijection between Dyck paths and trees. Let us now investigate how the definition of generalized Dyck paths interact with the tree decomposition of the family M .

9.4 GDP and tree-decomposition : back to the labeling.

For $n \geq 1$ the sets GD_n are strongly linked to some elements of the family M (see above), especially, the coefficients $M^{\binom{+, \dots, +, -}{x_1, \dots, x_{n-1}, x_n}}$. Because of theorem 5.1,

$$M^{\binom{+, \dots, +, -}{x_1, \dots, x_{n-1}, x_n}} = \sum_{(F, \phi_F) \in \mathcal{F}^{\binom{+, \dots, +, -}{x_1, \dots, x_{n-1}, x_n}}} M_{F, \phi_F}^{-, \mathbf{x}} \quad (9.37)$$

The forests in the set $\mathcal{F}^{\binom{+, \dots, +, -}{x_1, \dots, x_{n-1}, x_n}}$ are exactly the trees of Ca_n (see section 6). It means that the tree decomposition induces a partition of the set GD_n into ca_{n-1} subsets :

$$GD_n = \bigcup_{T \in Ca_n} GD^T \quad \text{where} \quad GD^T \stackrel{def}{=} \{(x_1, \dots, x_n) \in \mathbf{R}^n ; M_{T, \phi_T}^{-, (x_1, \dots, x_n)} = 1\} \quad (9.38)$$

The labeling were not explicit in section 5 but, for a better understanding of the above partition, we need to give a precise statement on the labeling of these trees.

Theorem 9.3 For $n \geq 1$, the forests of $\mathcal{F}_{(x_1, \dots, x_{n-1}, x_n)}^{(+, \dots, +, -)}$ are the trees of Ca_n . Moreover, if T be a tree of Ca_n , the labeling of this tree, as an element of $\mathcal{F}_{(x_1, \dots, x_{n-1}, x_n)}^{(+, \dots, +, -)}$, is given by one of the following procedures :

Procedure 1 :

- The root of T is labeled by x_n .
- Once this root is omitted, we get a forest of Fa_{n-1} having s trees T_1, \dots, T_s of size $\alpha_1, \dots, \alpha_s$ ($s \geq 1$). Note that each α_i is positive and $\alpha_1 + \dots + \alpha_s = n - 1$. We split the sequence (x_1, \dots, x_{n-1}) into s successive subsequences $X^1 \dots X^s$. The labels of the tree T_i are in the sequence X^i , and as the roots of these trees are at odd distance of the original root, we label them by the first element of their respective sequence X^i .
- We apply then the same procedure to each tree **but**, if the new root to label is at even distance of the original root, its label is not the first of the associated subsequence, but the last.

Procedure 2 :

- The root of T is labeled by x_n .
- Once this root is omitted, we get a forest of Fa_{n-1} having s trees T_1, \dots, T_s of size $\alpha_1, \dots, \alpha_s$ ($s \geq 1$). We split the sequence (x_1, \dots, x_{n-1}) into s successive subsequences $X^1 \dots X^s$. The labels of the tree T_i are those of $X^i = (x_{\tilde{\alpha}_i}, \dots, x_{\tilde{\alpha}_i})$ and the labeling of T_i is the same as the one encountered for this tree in the set $\mathcal{F}_{(x_{\tilde{\alpha}_i}, \dots, x_{\tilde{\alpha}_i}, x_{\tilde{\alpha}_i-1})}^{(+, \dots, +, -)}$ (the sequence is reversed).

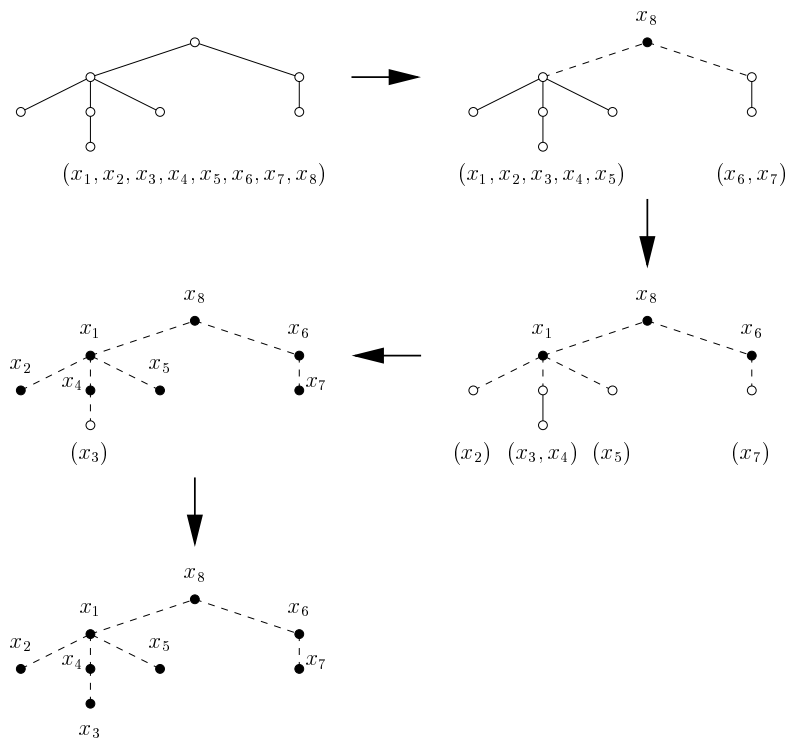


Figure 8: Labeling a tree.

The two procedures are obviously equivalent. This result is illustrated in figure 8, for a tree of $\mathcal{F}_{(x_1, \dots, x_7, x_8)}^{(+, \dots, +, -)}$

Proof : From section 5, we deduce the following results :

Fact 1 : Because of the construction in section 5, the set of labeled forests $\mathcal{F}_{(x_1, \dots, x_{n-1}, x_n)}^{(+, \dots, +, -)}$ is easily deduced from the set $\mathcal{F}_{(x_1, \dots, x_{n-1})}^{(+, \dots, +)}$ by adding a root labeled by x_n to the forest belonging to this set. It means that the sets to study are

$$\mathcal{F}_{(x_1, \dots, x_n)}^{(+, \dots, +)} \stackrel{def}{=} F^{x_1, \dots, x_n}$$

Note also that, omitting the labeling, the forests in the set $\mathcal{F}_{(x_1, \dots, x_n)}^{(+, \dots, +)}$ are exactly those of Fa_n and the forests in $\mathcal{F}_{(x_1, \dots, x_{n-1}, x_n)}^{(+, \dots, +, -)}$ are exactly the *trees* of Ca_n

Fact 2 : If

$$A^{x_1, \dots, x_n} \stackrel{def}{=} \{F \in F^{x_1, \dots, x_n} \text{ such that } F \text{ is a tree}\}$$

then $A^{x_1} = F^{x_1}$ has one element, the unique tree of size 1 labeled by x_1 , and for $n \geq 2$, we have the following properties :

- A labeled tree T of size n belongs to A^{x_1, \dots, x_n} iff : “the rightest son of its root is labeled by x_n , and there exists a unique k such that $1 \leq k \leq n - 1$, the forest *under*

x_n belongs to $F^{x_{k+1}, \dots, x_{n-1}}$ and the tree T amputated of the subtree starting at x_n belongs to A^{x_1, \dots, x_k} .

- A labeled forest F belongs to F^{x_1, \dots, x_n} iff there exist a decomposition of (x_1, \dots, x_n) in *successive* subsequences X^1, \dots, X^t ($t \geq 1$) such that F is a sequence of trees T^1, \dots, T^t with

$$\forall 1 \leq i \leq t, T^i \in A^{X^i}$$

Theorem 9.3 is clearly a consequence of these facts.

9.5 From GD_{2n} to D_n .

The set D_n is equipotent to the set Ca_n , and is a finite subset of GD_{2n} . The tree-decomposition of the family M induces a partition of the set GD_{2n} into ca_{2n-1} subsets that are indexed by the trees of Ca_{2n} . We will prove that this partition induces a bijection between D_n and a subset of Ca_{2n} that can be naturally identified to Ca_n and that, after identification, the bijection is the one described in section 9.2.

For $n \geq 1$, we remind that

$$GD_{2n} \cap \{-1, +1\}^{2n} = D_n \xrightarrow{\Psi_n} Ca_n$$

and

$$GD_{2n} = \bigcup_{T \in Ca_{2n}} GD^T$$

thus, it seems natural to study, for $T \in Ca_{2n}$, the set

$$\widetilde{GD}^T = GD^T \cap \{-1, +1\}^{2n} = \left\{ (x_1, \dots, x_{2n}) \in \{-1, +1\}^{2n} ; M_{T, \phi_T}^{-, (x_1, \dots, x_{2n})} = 1 \right\} \quad (9.39)$$

Let us first define the levels of a tree : the root is at level 1, its sons are at level 2 and so on

Theorem 9.4 *Let $T \in Ca_{2n}$ ($n \geq 1$), the set \widetilde{GD}^T is non-empty iff each vertex of T of odd level has exactly one son. In this case the set \widetilde{GD}^T contains one element (a Dyck path of length $2n$).*

Proof : Let us consider a tree T of Ca_{2n} and suppose that $(x_1, \dots, x_{2n}) \in \widetilde{GD}^T$. Each x_i is attached to a vertex and we can consider the partial sum s_i , with respect to the order induced by the tree : s_i is x_i plus its primogeniture. We can also associate a sign ε_i to each x_i , as in the tree-coefficient : ε_i is $+$ if x_i is the label of a vertex at even level and is $-$ otherwise.

In these conditions (see section 4),

$$M_{T, \phi_T}^{-, (x_1, \dots, x_{2n})} = \prod_{i=1}^{2n} \sigma_{\varepsilon_i}(s_i) = 1$$

thus,

$$\forall 1 \leq i \leq 2n ; \quad \sigma_{\varepsilon_i}(s_i) = 1$$

Suppose that x_i is the label of a leaf at an odd level, then $s_i = x_i = -1$. When we go “up”, its father is labeled by x_{i-} . s_{i-} is the sum of x_{i-} , $s_i = -1$, and other non positive partial sums associated to the other sons of x_{i-} . The sum s_{i-} is obtained by adding at most $x_{i-} = +1$ and $s_{i-} - x_{i-} \leq -1$ thus s_{i-} cannot be positive. It means that the leafs of T must be at even levels.

Let us now consider a vertex of T that is not a leaf, suppose that it is labeled by x_i and has k sons ($k \geq 1$) labeled by x_{i_1}, \dots, x_{i_k} . If this vertex is at an even level $s_i = x_i + s_{i_1} + \dots + s_{i_k} > 0$ whereas, for $1 \leq j \leq k$, $s_{i_j} \leq 0$: it implies that $x_i = +1$ and for $1 \leq j \leq k$, $s_{i_j} = 0$. If this vertex is at an odd level $s_i = x_i + s_{i_1} + \dots + s_{i_k} \leq 0$ whereas, for $1 \leq j \leq k$, $s_{i_j} > 0$: it implies that $x_i = -1$ and $k = 1$ and $s_{i_1} = 1$.

This proves that if \widetilde{GD}^T is non-empty then it satisfies the condition of the theorem. Conversely, starting with the leafs and going “up”, the above considerations shows that for, such a tree, the label x_i at odd (resp. even) level are equal to $+1$ (resp. -1) with partial sums $s_i = +1$ (resp. 0) : there is a unique Dyck path in the set \widetilde{GD}^T .

Let us define for $n \geq 1$:

$$C_n \stackrel{\text{def}}{=} \{T \in Ca_{2n} ; \widetilde{GD}^T \neq \emptyset\} \quad (9.40)$$

It is now obvious that this subset of Ca_{2n} is equipotent to D_n and to Ca_n . For $n \geq 1$, there was a first “natural” bijection Ψ_n between D_n and Ca_n ; the above theorem yields a second bijection Φ_n between C_n and D_n that associate to a tree T of C_n the unique Dyck path in \widetilde{GD}^T . We can consider the bijection $\Psi_n \circ \Phi_n$ that happens to be very simple :

Theorem 9.5 *For $n \geq 1$, the bijection $\Theta_n = \Psi_n \circ \Phi_n$ between C_n and Ca_n can be described as follows :*

Consider a tree $T \in C_n$, it is a tree of Ca_{2n} such that each vertex of T of odd level has exactly one son. If these vertices of odd level are glued with their respective unique son, such that the in between edges disappear, then a tree T' of Ca_n is obtained and $T' = \Theta_n(T)$.

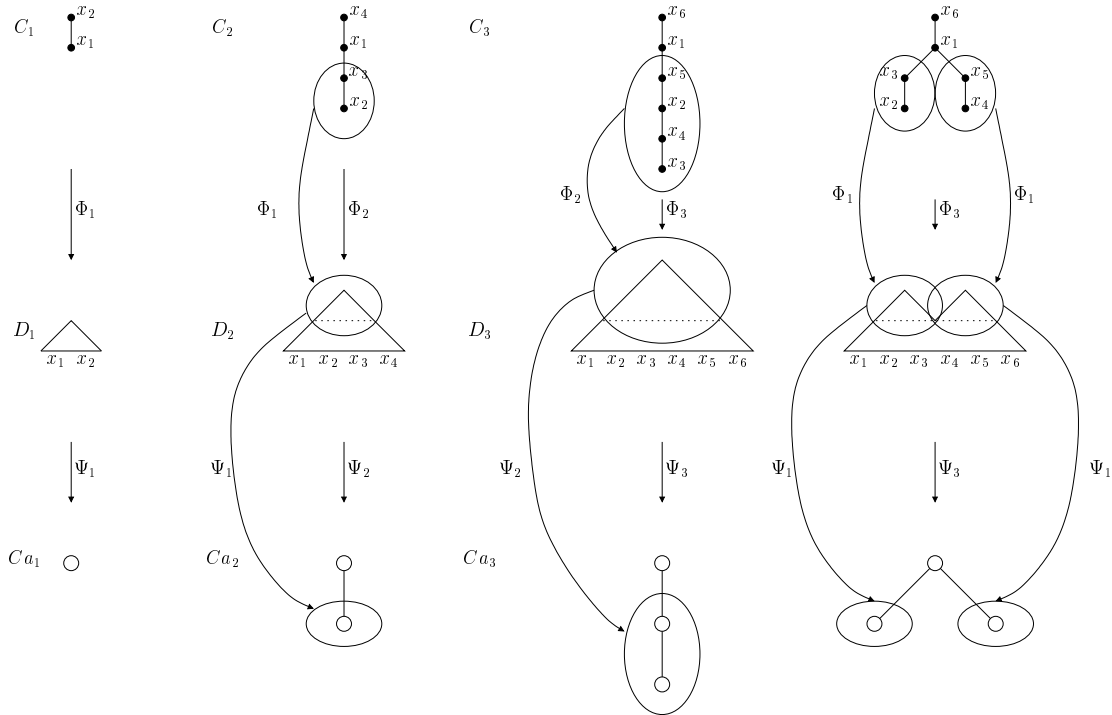


Figure 9: Illustration of the proof.

Proof : First consider that, starting from C_n , Θ_n is defined by the gluing procedure, then it remains to prove by induction that $\Theta_n = \Psi_n \circ \Phi_n$. The reader who wants to skip the proof can have a look to figure 9.

The result is obvious for $n = 1$. For a tree T in C_n ($n \geq 2$), consider its labeling, as an element of $\mathcal{F}_{(x_1, \dots, x_{2n-1}, x_{2n})}^{(+, \dots, +, -)}$ (it is described by theorem 9.3). As an element of C_n , its root is labeled by x_{2n} and its unique son is labeled by x_1 . Now, it becomes obvious, that omitting this edge ($x_{2n} - x_1$) in the tree T corresponds, for the path $\Phi_n(T)$ to omit the first (resp. last) step $x_1 = +1$ (resp. $x_{2n} = -1$) and because of the inductive definition of Ψ_n , it corresponds to omit the root in $\Psi_n \circ \Phi_n(T)$, as in $\Theta_n(T)$. Once this omission is done, we get k subtrees of T :

$$(T_1, \dots, T_k) \in Ca_{n_1} \times \dots \times Ca_{n_k} \quad (n_1 + \dots + n_k = 2n - 2)$$

As T is in C_n , the integers n_1, \dots, n_k are even and :

$$\forall 1 \leq i \leq k ; T_i \in C_{m_i} (m_i = n_i/2)$$

Looking at the induced labeling of these trees, the paths $\Phi_{m_1}(T_1), \dots, \Phi_{m_k}(T_k)$ are exactly those obtained once x_1 and x_{2n} are omitted and the trees $\Psi_{m_1} \circ \Phi_{m_1}(T_1), \dots, \Psi_{m_k} \circ \Phi_{m_k}(T_k)$ are those obtained from $\Psi_n \circ \Phi_n(T)$ once its root is omitted. By induction,

$$\forall 1 \leq i \leq k ; \Psi_{m_i} \circ \Phi_{m_i}(T_i) = \Theta_{m_i}(T_i)$$

and then $\Psi_n \circ \Phi_n(T) = \Theta_n(T)$. It ends the proof of this theorem.

10 Conclusion.

The proof of the Andersen's formula , as well as the results for the simple random walk, are the first applications of our tree decomposition. There is now doubt that this tool will provide other known, and hopefully unknown, formulas or properties for random walks.

Another application will be given in a coming paper. A complete answer will be given to the following question : when do two densities in $\text{Vect}_{\mathbf{R}}\{x \mapsto e^{-\lambda|x|} ; \lambda > 0\}$ induce the same average ?

A A note on the terminology.

We end this paper by a short explanation for the terminology of “averages induced by diffusion”. This denomination was given in the mathematical theory that originally motivated the author’s interest in random walk : the *resummation theory*. We briefly describe here the links between this theory and the random walks.

A specific set of probabilities associated to a random walk on \mathbf{R} has been called an average because this terminology was first adopted in resummation theory. The well-behaved uniformizing averages (WBA) were introduced by J. Ecalle in the framework real resummation, which aims at assigning a real sum to a real divergent series of “natural origin”, for example a formal solution of a differential equation. The need for “uniformizing” some analytic ramified functions appears naturally in this kind of problem. For example, let φ be an analytic function with singularities over \mathbf{N}^* , analytically continuable on the universal covering of \mathbf{C}/\mathbf{N}^* . For a given non-negative integer n we can label the 2^n determinations of φ over the interval $]n, n + 1[$ that are obtained by analytic continuation of φ along the 2^n paths dodging the singularities $\{1, \dots, n\}$ to the left or to the right. If the sign $+$ (resp. $-$) is assigned when dodging to the right (resp. to the left), these 2^n determinations of φ over $]n, n + 1[$ are labeled by the addresses $(\varepsilon_1, \dots, \varepsilon_n)$ ($\varepsilon_i = \pm$ and $1 \leq i \leq n$). Such functions appear naturally in the real-resummation theory and it is almost as natural to try to associate a uniform function to φ , that is to “uniformize” it. The simplest way is to do, over the interval $]n, n + 1[$, an “average” of the 2^n determinations of φ , pondering them by 2^n “weights” $\mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n}$, of sum (for a given n) equal to 1.

Thus, a *uniformizing average* \mathbf{m} is simply a collection of weights :

$$\mathbf{m} = \{ \mathbf{m}^{\varepsilon_1, \dots, \varepsilon_n} ; n \geq 0 ; \varepsilon_i = \pm ; 1 \leq i \leq n \} \quad (\text{A.41})$$

Some additionnal conditions, both analytic and algebraic, are imposed to such averages, so that they become a very powerful tool in real resummation. In these conditions, the average \mathbf{m} is called a *well-behaved average* (WBA). For details see [3, 4, 10, 11]. The study of particular averages, which appeared to be WBA, proved the existence of such objects, and, for example, J. Ecalle found a great class of WBA : the *averages induced by diffusion*.
